- B. Board approved Spencer Brown as long term substitute for Music teacher at OJ Neighbours effective November 17, 2025.

- C. Board accepted the resignation of Madison Inman as LH Carpenter's preschool teaching paraprofessional effective November 25, 2025.

- D. Board approved the ECA positions for the 2025-2026 school year.

- E. Board approved the following classified staff pay increases:

- F. Board approved a salary increase for Chad Niccum, Director of Maintenance, to \$65,000 effective January 1, 2026. This salary increase is in lieu of the 1.5% increase for classified staff.
